encourage more people to adopt children who have been languishing in the
foster care system. The Organization offers eligible families a home and a
supportive community with activities, programs, and services; it also offers
eligible older adult resident volunteers a home to provide basic support for the
families and to engage in activities within the village. Currently, there are 14 seniors,
23 adults and 42 children living at New Life Village. Six of the 42 children are
foster children and 23 are adopted or awaiting adoption. The remaining
19 children are birth children.
