NLV PROVIDES AN AFFORDABLE HOUSING PROGRAM FOR 52 HOUSEHOLDS. APPROXIMATELY 95% OF NLV RESIDENTS ARE BELOW 80% OF THE AREA MEDIUM INCOME MEANING THEY ARE LOW INCOME. BY PROVIDING AFFORDABLE AND ATTAINABLE HOUSING FOR OUR RESIDENTS, CAREGIVERS ARE ABLE TO SAVE FOR HOMEOWNERSHIP, REPAIR CREDIT, AND INVEST IN RAISING THE TRAUMA IMPACTED YOUTH IN THEIR CARE. NLV RENTS ARE OVER \$1,000/MONTH UNDER MARKET RATES FOR COMPARABLE RENTALS IN THE TAMPA AREA. AFFORDABLE 3 & 4 BEDROOM RENTALS ARE VERY RARE IN THE TAMPA AREA AND ALMOST ALWAYS HAVE SIGNIFICANT WAITING LISTS. OFTEN CAREGIVERS ARE IN NEED OF LARGE BEDROOM UNITS TO CARE FOR SIBLINGS GROUPS IN FOSTER CARE.
